# Swackhammer Stabilized!

#### Churchyard cemetery saved from destruction

In March 2013 several volunteers led by Jeff and the late Joan Chiu embarked on effort to clear and restore the grounds and cemetery of the long abandoned and overgrown site of the Mount Bethel Evangelical Lutheran Church, commonly called the "Swackhammer churchyard and cemetery." The church was founded in 1844 by Reverend Lambert Swackhammer and built by mason Jacob Swackhammer. Rev. Swackhammer left the church in 1850 and it was sold eventually to the Evangelical Lutheran Church of New Jersey in 1868. It was used until 1896 after which it was abandoned. http://www.thehistorygirl.com/2013/03/savinggrave-strangers-work-to-preserve.html. This year Mount Amwell Project funds and volunteers have nearly completed the work started by Jeff and Joan Chiu. They had cleared brush and trees as well as found and reset many headstones. Especially

impressive was the tree removal done by Jeff Chui and Chris Olewick.

There was a general cleanup in April of this year but by early June, the weeds had grown to several feet. A second cleanup was done and a neighbor was engaged to cut the grass every two weeks for the rest of the summer. It is anticipated this arrangement will continue in 2018.

In August this work was done to accommodate better and safer parking for visitors as well improve the site's appearance. LCW Contractors of Glen Gardner was employed to grade around the church ruins, remove stones fallen walls, and clear several tree stumps. Ron and Pat Barber, Dave Voorhees, and Jan and Dave Reading raked, seeded, and mulched the cleared area with new grass.

The Mount Amwell Project took possession of the site in 2015. The Lutheran Synod of New Jersey granted a quit claim deed to the MTAP. It was the culmination of the efforts of many people but primarily Joan Chiu, representing the Swackhammer group, and Tom Kull, Treasurer of the Synod. The Synod's governing board approved a resolution on 6 March 2014 to convey any interest in the Swackhammer property to the Mount Amwell Project. On June 17th 2014 the deed and associated paper work was hand delivered to the Hunterdon County Clerk's Office in Flemington for recording.

Language from the deed "Property was at one time previously owned and utilized by a group practicing the Lutheran religion. Grantor is unaware the duration of time that this group operated at the Property, when such operations ceases, or how title ownership of the Property has derived to the present. Pursuant to N.J.S.A. 16:5-26, all property owned by an incorporated Lutheran Church of New Jersey at the time such Church disbands, or ceases to function or conduct worship passes to and becomes vested in the synod with which the said Church is affiliated at the time of such default. The Grantor is one of sixtyfive (65) synods in the Evangelical Lutheran Church in America, and it is likely, though not subject to confirmation, that the Property would be within the territorial boundary of the Grantor through merger and succession. Accordingly, to the extent that the group practicing the Lutheran religion at the Property would have been deemed an incorporated Lutheran Church of New Jersey within the ambit of N.J.S.A. 16:5-26 such that title to the Property would have vested in the Grantor by operation of law, then Grantor is authorized to execute and deliver this Deed to the Grantee." The Swackhammer Cemetery was accepted as the first historic (non-active) member cemetery of the New Jersey Cemetery Association. Membership provides us with access to legislative advocates at the state level for monitoring cemetery legislation. Significant work was done in 2017 to clear and put maintenance procedures in place for the four cemeteries that we are currently responsible for: the Swackhammer as described in the current article, the Haypress, the Reading Burial Ground, and the Slacktown. We supported the legal efforts for Stockton Borough to obtain ownership of the Howell Graveyard. It is anticipated that this work will be completed in 2018 and the MTAP will have an additional cemetery to clear and maintain.
